

- 1. Relative to DM No. 46, s. 2023 Re: Guidelines on the Conduct of Coaching and Mentoring Sessions for the National Qualifying Examination for School Heads 2021 Category B Aspiring School Heads, the concerned Schools Division Offices (SDOs) with takers who fall under Category B shall identify outstanding principals who will serve as coaches and mentors.
- 2. The identified outstanding principals who shall serve as coaches and mentors should meet the qualifications as indicated in the said Memorandum and are encouraged to use the existing NEAP SHDP material (https://bit.ly/SHDPmaterials) or any training materials for school heads provided that the topics are aligned to the PPSSH.
- 3. Schools Division Offices should exercise responsibility in considering the most appropriate and convenient arrangement for the coach and mentor, and the designated Public Schools District Supervisor to monitor the implementation of the coaching and mentoring sessions.
