Terminal Objective:

Enabling Objectives:

- a. Orient LF nominees/candidates and assessors on the assessment processes, procedures and standards;
- b. Apply the policy and implementing guidelines and assessment areas to LF nominees/candidates;
- c. Recommend and recognize LF nominees/candidate who meet the certification standards;
- d. Evaluate the implementation of accreditation and Certification System/activities with field implemented implementers.

Expected Output:

- a. A pool of DepEd Assessors is organized and equipped on the use of processes and standards set at the Learning Facilitators Policy and Implementing Guidelines;
- b. Applied LF Certification Policy and standards to recommend Learning Facilitators;
- c. A pool of competent certified Learning Facilitators that will form part of the Academy's Faculty member who will spearhead the conduct of continuing professional development across governance levels; and
- d. Threshed-out related issues and improved succeeding implementation of Accreditation and Certification of Learning Facilitators.
