

Under Chapter IV of COMELEC Resolution no. 10924 on "Emergency Accessible Polling Place (EAPP) For Persons with Disabilities, Senior Citizens, and Heavily Pregnant Women," an EAPP is an option given the aforementioned vulnerable sectors who may experience challenges in terms of accessibility to their regular polling places on election day, in addition to the Accessible Polling Place (APP) wherein an established/clustered precinct or polling place is places at the ground floor of voting centers exclusive for SCs and PWDs.

In relation to the preparations for the October 30, 2023 Barangay and Sangguniang Kabataan Elections (2023 BSKE), this Office requests for the provision of spaces, including but not limited, to the following:

- Tents;
- Covered courts;
- Principal's office;
- Clinics;
- Library;
- Nursery classrooms;
- · Makeshifts near the gate or entrance of the school; and
- Any spaces available.

For your reference, attached herein is a list of the EAPP makeshifts that are supposed to be constructed if we will not provide alternative classrooms and such other options for the establishment of EAPPs in the voting centers.

Moreover, relative to the request of COMELEC, there will be an extension of the conduct of training of the electoral boards. In the exigency of service, training is allowed to be conducted on weekdays.
