

- 1. The Philippines is susceptible to geological and hydro-meteorological hazards. Being a disaster-prone country, it is imperative to raise awareness and increase knowledge, skills and attitudes, and values needed to survive any challenges due to these hazards.
- 2. This Office, through the Education Support Services Division (ESSD) shall conduct a writeshop on the Development of DRRM advocacy/learning materials for Grades (2000) on November 14-16, 2023 (venue to be announced).
- 3. Each schools division shall send the following participants: 2 school heads, 1 district DRRM Coordinator/education supervisor and 1 PDO II (DRRM). Regional participants are identified personnel from the Curriculum and Learning Management Division and Education Support Services Division (Enclosure 1).
