Qualification Standards and Procedures for the Recruitment, Screening and Selection of Evaluators

1.a) Minimum Qualification Standards for Evaluators

- With at least five (5) years teaching experience in the learning area being applied;
- ICT literate (has active DepEd email and Microsoft 365 account familiar in downloading and uploading files, can edit online files word, pdf, videos, LMS course packages and other digital/non print learning resources, can open zip files); and
- Is physically fit, willing, and able to travel to attend and participate in actual content evaluation activity lasing from three to five days and which may not be held in his/her province/city.

1.b) Submission of Documents

The evaluator applicants shall submit the following documents to the Regional LRMS:

- Application Letter addressed to the Regional Director;
- Application Form (see Enclosure 2);
- Photocopy of Service/Work Record; and
- Photocopy of specialized and relevant seminars/trainings (from 2018 to present); and
