



- 1. Relative to the upcoming implementation of the **Project Class-In Connect** in the region starting SY 2024, this Office through the Curriculum and Learning Management Division (CLMD) announces the conduct of the **Phase 1 Learning Delivery Design on Literacy, Numeracy and Science for Key Stage 1 Learners** on January 30 to February 2, 2024 at SNC Hall, DepEd CAR, Regional Office, Wangal, La Trinidad, Benguet.
- 2. The activity aims to develop learning designs that are appropriate in facilitating the learning of Key Stage 1 learners in CAR using Class-In as a platform. It also aims to gather functional learning materials in digital form for Math, Science and English in Key Stage 1.
- 3. All Schools Division Offices are requested to send participants with the following qualifications.
 - must be currently teaching as a Master Teacher at the elementary level and must be currently implementing ICT integration in blended learning (preferably in Key Stage 1 for Master Teachers)
 - must be currently leading an Elementary School (for School Heads)
 - must be actively engaged and in ELLN activities (for EPSs)
 - must be highly familiar with the use of educational technology in teaching Math, Science and English especially for Key Stage 1 learners
 - must have an-in depth knowledge on various teaching strategies and online and offline modalities of teaching in the foundational stage
- 4. Each Schools Division Office shall identify qualified participants based on the following table.

- Participants from each SDO shall bring the following:
 - laptop, extension cords and data on the least learned learning competencies in Math, English/Reading and Science from Grades 1 to 3 (Key Stage 1) based on the result of FLAT, EGRA, EGMA
 - data on the Top 20 Schools having the lowest results along the identified subject areas based on the results of any assessments conducted or based on the learners' academic performance for SY 2022 -2023.
 - soft copies of quality assured learning materials for the identified learning areas or bring compilations or repository of learning activities that may be used for online and offline learning sessions through educational technology.
 - summative assessment for Grade 1 to 3 along the three subject areas with TOS
- 6. Expected arrival of participants at the venue will be on **January 29** in the evening. First meal to be served is **dinner Day 0 (January 29)** and last meal is PM snacks of Day 4 **(February 04)**.
- 7. This Office interposes no objection on the participation of the teachers provided that time-on-task policy shall be observed based on DepEd Order No. 09, s. 2005 to ensure that learning shall not be disrupted and continued for the benefit of the learners. In particular, there shall be relieving teachers to handle the classes of the teacher-participants.
- 8. Travel expenses and other incidental expenses of the participants shall be charged against the local funds subject to the usual accounting, budgeting and auditing rules and regulations.
