Subject: **Call for Assigned Writers on the Submission of Developed Grade 10 Modules in English, Math, Edukasyon sa Pagpapakatao, and Technology and Livelihood Education**

1. Due to the extension of the quarantine period until April 30, 2020 as a measure against further spread of COVID 19, the scheduled conduct of evaluation of the Grade 10 ADM modules for Quarters 2 to 4 assigned to our region by the Bureau of Learning Resources of the Central Office has to be cancelled. However, our present situation calls for a contingency measure that includes the use of ADM modules which are needed for the continuous delivery of quality basic education.
2. Relative to the aforementioned, the DepEd Bureau of Curriculum and Instruction and Bureau of Learning Resources called the attention of all Regional CLMD Chiefs and ADM Focals to expedite the submission of assigned modules to the region from Q1 to Q4 for the CO to process in time for school opening this SY 2020 to 2021.
3. In connection, the Schools Division Offices, through the Curriculum Implementation Division and the ADM focal persons, are requested to facilitate the immediate online submission of the soft copies of Q1 to Q4 modules in Grade 10 English, Math, EsP, and TLE on or before **April 30, 2020** through clmd.deped@gmail.com.ph (Attention: ADM Focal Person).
4. For guidance, the following were the assignments for CAR as agreed upon by all CID chiefs/representatives as early as summer of 2019, during a gathering facilitated by the Central Office in Tanza Oasis Hotel and Resort, Tanza, Cavite. 
