**CONDUCT OF TELECONFERENCING/WEB CONFERENCING
TO FINALIZE THE DIVISION CONSOLIDATED DRAFT OF THE
GENDER RESPONSIVE AND NON-DISCRIMINATORY
STUDENT DISCIPLINE (GRaNdSDisM) MANUAL**

1. The 1st Quarter Interface of RO and SDO Key Personnel proving Legal Services cum Drafting of the Gender Responsive and Non-Discriminatory Student Discipline (GRaNdSDisM) Manual was scheduled on March 18-20, 2020;
2. However, due to the Covid-19 pandemic, the entire Luzon was placed under Enhanced Community Quarantine (ECQ) from March 17 to April 12 which was extended to April 30, 2020;
3. In light with the ECQ, a work from arrangement for employess under the Executive Department is being implemented, except those identified as providing frontline services;
4. selected representatives of the concerned stakeholders as per DepED CAR RM 54 s 2020;

6. The Division draft shall be submitted to the Legal Unit thru email at *legalunit.depedcar@gmail.com* not later than April 27, 2020. A regional teleconferencing/web conferencing will be conducted on April 30, 2020 to be participated by at least one representative per Division TWC to consolidate the drafts, and come up with a draft Regional GRaNdSDisM Manual to be presented to DepEd CAR EXECOM;
7. Participants to the teleconferencing/web conferencing are the identified Technical Working Committee (TWC) of the GRaNdSDisM Manual, and selected stakeholders to be identified by the Division TWC;
8. Participants to the teleconferencing/web conferencing not receiving communication allowance shall be entitled to a load allowance in the amount of Php300.00, charged to local funds.
