

### CONDUCT OF THE BRIGADA ESKWELA FOR SY 2024-2025

To: Schools Division Superintendents
All Others Concerned

- 1. This Office, through the Education Support Services Division, with the Eight (8) Schools Division Offices shall conduct the annual implementation of the Brigada Eskwela (BE) Activities on **July 22-27**, **2024**. This is consistent with DepEd Order (DO) No. 003, s 2024, titled Amendment to DepEd Order No. 2023 (Implementing Guidelines on the School Calendar and Activities for the School Year 2023-2024).
- 2. The Brigada Eskwela (BE) is a nationwide school maintenance program that engages all education stakeholders to contribute their time efforts and resources in ensuring that public schools are all set in time for class opening. It is a six-day event where local communities, parents, alumni, civic groups, local businesses, non-governmental organizations (NGOS), private individuals, and even teachers and students volunteer their time and skills for the conduct of clean ups, minor to medium repairs and maintenance work in classrooms and within the school sites.
- 3. The implementation of the 2024 Brigada Eskwela with the theme "Bayanihan Para sa Matatag na Paaralan", shall follow the mechanics provided under DO 021,s, 2023, titled Brigada Eskwela Implementing Guidelines.
- 4. To kickstart the weeklong activity of the Brigada Eskwela, Schools Division Offices identified schools to kick off on **July 22**, **2024**, simultaneously with schools. The DepEd-CAR -Regional Office will conduct the Gulayan sa Opisina in Wangal, La Trinidad, Benguet, on **July 24**, **2024**.

### AMENDMENT TO DEPED ORDER NO. 003, s. 2024

(Amendment to DepEd Order No. 022, s. 2023 [Implementing Guidelines on the School Calendar and Activities for School Year 2023-2024)) AND START AND END OF SCHOOL YEAR 2024-2025

To: Undersecretaries Assistant Secretaries Bureau and Service Directors Minister, Basic, Higher and Technical Education, BARMM Regional Directors Schools Division Superintendents Public Elementary and Secondary School Heads All Others Concerned

- The Department of Education (DepEd) remains steadfast in its commitment to ensure the health, safety, and well-being of learners and teachers, as articulated under the MATATAG Agenda.
- To fulfill this commitment, DepEd, with the guidance of the Office of the President, recognizes the urgency of reverting the school calendar to the pre-pandemic opening of classes.
- In view of the foregoing, the provision of Paragraph 6, specifically bullet 4 of DepEd Order (DO) No. 003, s. 2024, Amendment to DepEd Order No. 022, s. 2023 (Implementing Guidelines on the School Calendar and Activities for School Year 2023-2024) shall be amended and read as follows:
  - Start and End of SY 2024-2025. SY 2024-2025 shall start on July 29, 2024, Monday and end on April 15, 2025, Tuesday.
- All Orders and issuances inconsistent with this Order are repealed or modified accordingly. All other provisions stated in DO 003, s. 2024 and DO 022, s. 2023, not affected by these amendments, shall remain effective.
- 5. This Order shall take effect immediately upon approval and after publication on the DepEd website and registration with the Office of the National Administrative Register (ONAR) at the University of the Philippines Law Center (UP LC), UP Diliman, Quezon City.
