

## REQUEST FOR INQUIRY AND VERIFICATION OF ESC AND SHS-VP PROGRAM BENEFICIARIES WITH LEARNER INFORMATION SYSTEM (LIS) FINDINGS

- 1. Relative to DepEd Memorandum OUF-2024-0521 to validate Education Service Contracting (ESC) and Senior High School Voucher Program (SHSD-VP) beneficiaries, the Government Assistance and Subsidies Service Composite Team is requesting assistance to submit Narrative Report on the following:
  - a. Identify discrepancies on the claims and allegations of the private schools that learners were enrolled in their schools during time of billing against the statements to be gathered from the learners themselves, teachers, school heads, Schools Division Superintendent (SDS), and/or other concerned individuals; and
  - b. Ascertain how the schools obtained the names and Learner Reference Numbers (LRNs) of the learners.



This refers to the ongoing initiative of the Government Assistance and Subsidies Service (GASS) to validate Education Service Contracting (ESC) and Senior High School Voucher Program (SHS-VP) beneficiaries to ensure the accuracy and legitimacy of the billing statements submitted by participating schools.

As a result of the validation process, we have identified inconsistencies between the information provided in the billing statements and the Learner Information System (LIS), particularly concerning the schools where the learners were reported to be enrolled.

In view of the foregoing, we respectfully request your assistance in the following matters:

- 1. Conduct an inquiry into the discrepancies identified by verifying the claims/allegations of the private schools that learners were enrolled in their schools during the time of billing against the statements to be gathered from the learners themselves, teachers, schools' heads, school division superintendents, and/or other concerned individuals; and
- 2. Ascertain how the schools obtained the names and Learner Reference Numbers (LRNs) of the learners.

We kindly request the submission of your findings by July 31, 2024.
