Subject : REGIONAL TRAINING OF TRAINERS ON THE CONTEXTUALIZATION OF THE

CURRICULUM FOR INDIGENOUS PEOLES EDUCATION (IPEd)

Date: January 5, 2016

- 1. Pursuant to Republic Act No. 10533, the Enhanced Basic Education Program and the IPEd provision of its Implementing Rules and Regulations (sec. 8.4), mandates DepEd to develop a curriculum that is culture-sensitive, contextualized, and flexible enough to enable and allow schools to localize, indigenize and enhance based on the specific educational and social context of communities. In support of this mandate, the Department of Education-Cordillera Administrative Region will conduct a four (4) day regional training-workshop on January 24-27, 2016 at the NEAP-R, Wangal, La Trinidad, Benguet.
- 2. The objectives of this training- workshop are the following:
 - a. Discuss the National updates on curriculum contextualization and its implications for k to 12 at the national level and at the regional level
 - b. Differentiate the IKSPs and ILS, and explain the relationship of the two
 - c. Developed and finalized indigenized lesson plans
 - d. Prepare plan for the division rollout of the contextualization of lesson plans
