- 1. Pursuant to DepEd Memorandum No. 158, s. 2015, the Department of Education, Cordillera Administrative Region (DepEd-CAR), through the Curriculum and Learning Management Division shall conduct the 2016 Regional Festival of Talents consisting of skills exhibition in Sining Tanghalan (Arts), National Population Quiz and On-the-Spot Skills Exhibition on PopDev (Araling Panlipunan), and Pambansang Tagisan ng Talino (Filipino) at DepEd-CAR, Wangal, La Trinidad, Benguet on February 2, 2016 in preparation for the National Festival of Talents to be held at General Santos City on February 22 to 25, 2016.
- 2. The Festival aims to:
 - Provide the secondary school learners with opportunities to showcase their talents through exhibitions of performances as evidence of their learning.
- 3. The area for skills exhibition are as follows:

- 5. Participants to these activities are the Division Level First Place winners, their coaches and the Division EPS/Coordinator in Sining Tanghalan, PopDev and Tagisan ng Talino.
- 6. All first place winners in the different contests categories shall represent the Region in the 2016 National Festival of Talents.

- 7. The meal (lunch) and two snacks (AM & PM) and prizes during the conduct of the festival shall be charged to Regional Funds, while the lodging, transportation, materials to be used by the contestants and other incidental expenses shall be charged to local funds subject to the usual accounting rules and regulations.
