

REPORT ON STATUS OF BE-LCP IMPLEMENTATION

TO: OIC-Assistant Regional Director Schools Division Superintendents All Schools Division Offices All Others Concerned

- 1. Pursuant to the implementation of the BE-LCP, this Office through the Curriculum and Learning Management Division (CLMD), requests submission of reports relative to the Status of BE-LCP implementation across all Schools Division Offices.
- 2. The objective of this endeavor is to:
 - a. Gain insights on how curriculum programs and projects in the light of the BE-LCP are being implemented and how they can be improved;
 - b. Recommend concrete strategies and activities to ensure effective implementation of programs and projects to improve learning outcomes; and
 - c. Identify best implementation practices relative to the strategies set out by the BE-LCP based on experiences shared by the field implementers.
- 3. Reports shall be submitted on or before January 15, 2021 through email address: clmd.depedcar@gmail.com and shall respond to these guide questions:
 - a. What learning delivery programs in light of BE-LCP are being conducted or implemented in your SDO? Provide descriptions of the programs and describe ways on how these programs have improved the target learning outcomes.
 - b. What specific and localized strategies, initiatives, or good practices have been employed/adopted by your SDO to support or to successfully implement the said learning delivery programs?
 - c. What are the issues, concerns, challenges that your SDO has encountered in the conduct or implementation of the learning delivery programs? To what extent do these issues, concerns, or challenges affect the program implementation?

Discuss both those that were already resolved and those that have remained to be resolved? How did you resolve or how will you plan to resolve bottlenecks?
