

LEARNING DELIVERY MODALITY (LDM) READINESS MIDLINE ASSESSMENT AND TRACKERS

- 1. Pursuant to Memorandum OSEC-NEAPOD-OM-2021-003 dated January 20, 2021 entitled "LDM Readiness Midline Assessment, and Submission Updates," the National Educators Academy of the Philippines Cordillera Administrative Region (NEAP CAR), reiterates the following:
 - a. As part of the after-training activities of the LDM 1 course (Management of LDM Implementation) for school heads, the NEAP Central is directing school heads to access and accomplish the LDM Readiness Assessment Tool (LDM RAT) for Quarters 2 to 4 (midline assessment) through bit.ly/ldmready234 on or before February 5, 2021 (Friday).
 - b. An end-line assessment tool will be deployed after the fourth grading period to help you track the LDM implementation progress you have made this school year. Data generated from the RAT (midline and end-line) will form part of the practicum portfolio and may also be used by school heads and other offices for action planning, progress monitoring, and decision-making. The tool and submission details are posted in the given link.
 - c. LDM focal persons in the SDOs are also instructed to do the following:
 - Update their SDOs LDM trackers through bit.ly/ldmneaptrackers; and
 - ii. Submit/upload LDM evaluation forms (Forms 1,2 and 4) to your respective Google drive folder. Submission details are shared in the following links:

2. Relative to this, the designated SDO Form Managers are requested to monitor the completion of the LDM 1 and 2 pre-implementation outputs and corresponding evaluations in the provided links. The form managers should also remind the designated LDM 1 LAC Leaders and LDM 2 Instructional Coaches to submit their required outputs in soft copies in the provided links for evaluation of Regional Office Coaches. The deadline set in the RM 413, s. 2020 was January 6, 2021, which shall be extended to January 30, 2021.

- 3. The Regional Office Coaches are also required to access the link for them to evaluate the outputs of LDM 1 LAC Leaders and LDM2 Instructional Coaches. The deadline for the upload of evaluation shall be February 12, 2021.
