

CONDUCT OF THE REGIONAL ALTERNATIVE LEARNING SYSTEM PROGRAM IMPLEMENTATION REVIEW (ALS-PIR)

- 1. The Curriculum and Learning Management Division (CLMD) will conduct the Regional Alternative Learning System Program Implementation Review (ALS-PIR) on February 11 -12, 2020 (exclusive of travel dates) at Flora Suites and Inns, Flora, Apayao.
- 2. The Activity aims to:
- a) assess the progress of the program FY 2019 implementation;
- b) determine issues and concerns that affect the program implementation;
- c) validate data gathered from the EBEIS for FY 2020; and
- d) provide technical assistance to the ALS implementers in designing appropriate contextualized intervention program per SDOs; and
- e) provide updates on the Alternative Learning System program implementation.
- 3. Participants are the CLMD Chief, CID Chief of the host division, Regional ALS-EPS, Division ALS EPSs/Focals and EPSAs. Participants are requested to bring laptops, portable wifi, updated data on the mapped-out learners, actual enrollment, program of activities per implementer, and other related data needed. Power Point presentation of accomplishment per SDO following the attached template is requested.
- 4. The first meal to be served will be dinner on February 10, 2020 and the last meal will be dinner on February 12, 2020. Board and lodging shall be charged against the ALS fund downloaded to SDO Apayao, while travel expenses shall be charged to local funds subject to the usual government accounting and audit rules and regulations.
