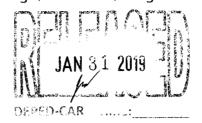

SCREENING OF APPLICANTS FOR THE NATIONAL EDUCATORS ACADEMY OF THE PHILIPPINES (NEAP) REGIONAL FACILITATORS' POOL

- Pursuant to NEAP Memorandum OM-GO-2016-NEAP-004, this Office through the Human Resource Development Division announces the 6th conduct of the screening of applicants for the National Educators Academy of the Philippines (NEAP) Regional Pool of facilitators to be held at the NEAP R, Wangal, La Trinidad on February 20-22, 2019.
- 2. The said activity aims to select additional members of the NEAP Regional Facilitators' Pool for the upcoming learning and development programs/activities to be conducted by DepEd-CAR.
- 3. Applicants to the Regional Pool of NEAP Facilitators should possess the following qualifications:
 - a. Permanent personnel, preferably Head Teacher, Principal, EPS II, SEPS, PSDS, EPS
 - b. Physically fit and preferably 55 years old and below
 - c. Must have been trained as trainer/facilitator
 - d. Must have a performance rating of at least VS for the last two years; and
 - e. Must be a computer proficient.
- 5. Applicants shall submit to the Human Resource Development Division the following duly accomplished documents not later than 5:00 PM on February 13, 2019; and for those who have already submitted their documents last November 17, 2017, they still need to submit letter of intent to update their application.
 - a. Application Form (Annex 1)
 - b. Character Reference (Annex 2)
 - c. Medical Certificate from accredited government physician/hospital indicating physical fitness to train and travel
 - d. Performance rating for the past two years (2 years)
 - e. Letter of recommendation from immediate supervisor (Annex 3)
 - f. Letter of Commitment signifying willingness to train anywhere in the country (Annex 4)
 - g. Certificate of no pending criminal and/or administrative case from the division
 - h. Certificate of participation/completion/attendance to training of trainers' program attended
 - Certificate of recognition/commendation/merit/etc. given as facilitator/ trainer/resource speaker, etc.
