- 1. In line with Republic Act (RA) No. 10533 or the Enhanced Basic Education Act of 2013 that aims to further strengthen decentralization efforts at the school level, the Regional Office will develop a Knowledge Management Information System (KMIS) for School-Based Management (SBM). Hence, SDOs and schools are requested to submit implemented best practices on SBM.
- 2. The submission of best practices aims to identify and include in the KMIS the best practices implemented in the school on SBM.
