2016 REGIONAL ASEAN QUIZ AND 74TH ARAW NG KAGITINGAN AND PHILIPPINE VETERANS WEEK: NATIONAL CREATIVE **PAINTING AND ESSAY WRITING CONTESTS**

- 1. Pursuant to DepEd Memorandum No. 36, s. 2016 and Unnumbered DepEd Memorandum dated March 4, 2016, the Department of Education, Cordillera Administrative Region (DepEd-CAR), through the Curriculum and Learning Management Division shall conduct the 2016 Regional ASEAN Quiz , Creative Painting and Essay Writing Contests in celebration of the 74th Araw ng Kagitingan and Veterans Week with the theme,"Isabuhay ang Kagitingan, Isulong ang Kapayapaan, Kamtin ang Mithing Kaunlaran." The said activity will be conducted at DepEd-CAR, Wangal, La Trinidad, Benguet on March 29, 2016.
- 2. The Quiz and contests aims to:
 - Foster the spirit of healthy competition among learners in a friendly quiz on ASEAN cultural, political, economic, and social transformation.
 - Increase awareness of the Araw ng Kagitingan as a shining moment of courage and commitment of freedom by our veterans.
- 3. The guidelines and criteria for each of the contest events are contained in DepEd Memorandum No. 36, s.2016 and Unnumbered DepEd Memorandum dated March 4, 2016 respectively.
- 4. Participants to these activities are the Division Level First Place winners in the three competitions, their coaches and the Division EPS/Coordinator in Araling Panlipunan.
- 5. The first place winner in the Quiz Bee shall represent the Region in the 2016 National Quiz to be held on April 5 to 8 at PTV Inc., Visayas Avenue, Quezon City while the adjudged Regional 1st Place Winners in the Essay Writing and Poster Making Contest will be submitted to the DepEd Central Office for National Judging.
- 6. The meal (lunch) and two snacks (AM & PM) and prizes during the conduct of the contest shall be charged to Regional Funds, while the lodging, transportation, materials to be used by the contestants and other incidental expenses shall be charged to local funds subject to the usual accounting rules and regulations.
