



- Relative to the agreement on the submission of LRs to the Region during the Convergence of K to 12 /Indigenous Peoples Implementers February 18-20 at the NEAP-R the following agreements were achieved:
  - a. Ten (10) LRs plus one (1) ALS locally developed LR from the least learned competencies, critical contents or identified learning gaps in any Learning area and Grade level per SDO shall to be submitted quarterly based on the following schedule:

- b. The LRs are expected to be packaged with DLL, and with attachments of the QA Forms CO form 7.10 (IPR), Form 7. 20 (Educational Soundness) Form 7.6 (Evaluation for the development of new print resource) Form 7.8 (Non-Print Evaluation Form) Form 7.14 (Social Content Evaluation) and CAR QF-CLMD-LRMDS -02 (Validation for Contextualization/ Elders Certificate/ FPIC).
- c. Locally developed LRs for quarterly submission shall undergo <u>thorough review</u> <u>and quality assurance</u> at the division level to facilitate uploading to the portal.
- d. **Performance** shall be submission versus the number of **uploaded** and **published** to the portal per division per quarter.
