

REGIONAL MEMORANDUM

IDENTIFICATION OF EXISTING DEPED ORDERS OR POLICIES FOR FEEDBACK

- 1. In line with the commitment to continuously improve and ensure the relevance, effectiveness, and sustainability of the Department's policies and issuances in reference to the office function version 3 on Policy Review and Monitoring, this office through the Policy, Planning, and Research Division (PPRD) hereby encourages all schools' division offices to identify existing DepEd Orders or policies that require feedback regarding their implementation. This aims to enhance, modify, or recommend the rescission of policies/DepEd orders in support of better curriculum implementation, learning delivery, and learning resource management and to recommend evidence-based adjustments to policies for continuous improvement and sustainability.
- 2. Relative to this, all schools' division offices shall:
 - a. *Identify policies for feedback*. Conduct a review/inventory of existing DepEd Orders or policies relevant to your division's functions align to the 5-Point Reform Agenda and identify those that require feedback or further evaluation.
 - 5 Point Reform Agenda:
 - 1- Invest in Teacher Quality and Equip them with Skills and Resources
 - o Professional development and merit-based career progression for teachers
 - o Teachers resources
 - o Teachers teaching load
 - 2. Build Classrooms, and Safe Supportive Learning Environments
 - o Promotion of health and nourishment (e.g. School-based feeding, zones of peace)
 - Ensure campuses are safe-spaces (e.g. RA 10627-Anti Bullying Law, Strengthening the LRPO)
 - Proactive support channels (e.g. DepEd order on hiring of guidance counselors)
 - o Digital spaces for learning and teaching
 - Policies governing the planning, construction, and maintenance of school facilities.

3. Enable Efficiency through Evidence-based Policymaking and Decentralized, Digital Processes.
