

## CONDUCT OF REVIEW AND ENHANCEMENT OF THE REGIONAL ACHIEVEMENT TEST

- 1. Relative to the conduct of the Regional Achievement Test (RAT) for SY 2023- 2024, a review and enhancement of RAT tools will be conducted on **March 13-15, 2024** to be held at DepEd CAR NEAP, Wangal, La Trinidad, Benguet.
- 2. The activity aims to review and enhance the RAT tools aligned with  $21^{\rm st}$  century skills and solo framework in assessing learner's outcome.

- 4. The learning area focus on the enhancement of the regional assessment test are Mathematics, Science, English, Filipino and Araling Panlipunan.
- 5. Schools Division Offices are requested to send the Education Program Supervisors in ESM, Fil and Aral pan or school heads with major in Mathematics, Science, English, Filipino or Araling Panlipunan to help in the enhancement of the RAT tools.
