

- Please be informed that a total amount of Four hundred fifty thousand pesos (PhP 450,000.00) under FY 2021 (continuing) Flexible Learning Options (FLO) fund has been downloaded to your divisions for the provision of learning resources and required materials/needs/supports for the implementation of Virtual Classroom learning delivery for SY 2021-2022.
- 2. The Virtual Classroom Learning Delivery is the implementation of the Basic Education Learning Continuity Plan (BE-LCP) which focus on online teaching and learning environment where teachers and learners can engage and interact with one another in a live, and synchronous setting.
- 3. The funds shall be utilized for the same purpose and considerations provided in DepED Order (DO) No. 18, s. 2020 and the Joint Memorandum No. DM OUCI 2022-029 (Supplementary Guidelines in the Utilization of Additional Funds for Provision of Learning Resources for SY 2021-2022) dated February 4, 2022 which states that funds shall be released to cover the deficiencies in the provision of learning resources and required devices in support of the adopted learning delivery modality.
