DEVELOPMENT OF LEARNING MATERIALS CUM QUALITY ASSURANCE FOR K-12 SULONG EDUKALIDAD IN THE NEW NORMAL

- 1. In cognizant to Article XIV Section 1 Paragraph 1 of the Philippine Constitution which states; "The state shall protect and promote the right of all citizens to quality education at all levels, and take appropriate steps to make such education accessible to all", this constitutional provision guarantees that all Filipinos regardless of status in life must receive quality education through relevant-teaching learning process and quality learning resources.
- 2. DepEd order no. 012 s. 2020 through the Sulong Edukalidad campaign underscores the commitment of the department in ensuring the health, safety, and well-being of learners, teachers, and personnel while finding ways for education to continue amid the crisis and remaining committed to the goal of delivering accessible, quality, liberating, and safe basic education services.
- 3. Knowing that this period of new normal shall be approached with compassion and sensitivity so that the process of learning will not be a burden for parents, children and teachers, but a ray of hope amid the crisis, DepEd-CAR through the HRDD and CLMD-LRMDS and its Project REALM, will conduct a webinar in the development of learning materials cum quality assurance to support and capacitate teachers, school heads and supervisors in developing LMs and ensure that LRs developed are aligned with curricular requirements, suitable and responsive to learners' context and have been subjected to rigid QA standards before utilization.
- 4. The webinar which utilizes the route of google meet comes in two batches; the first batch to be conducted on July 21-24, 2020 with SDOs of
