Members:	Chief of the Division/Unit where the vacancy exists ^(DO 66 s.2007) , or his/her designated alternate ^(ORA-OHRA)
	Chief, Administrative Division ^(DO 66 s. 2007) , or his/her designated alternate ^(ORA-OHRA)
·	Chief Administrative Officer V (HRMO III) (DO 66 s.2007), or his/her designated alternate(ORA-OHRA)
	One representative of the DepED Employees' Union, either for the first or second level, as the case may be(DO 66 s.2007), or his/her alternate representative(ORA-OHRA)
