# CONDUCT OF TELECONFERENCING/WEB CONFERENCING TO CASCADE THE REGIONAL POLICY ON GRANDSDISM

- 1. Last May 27, the DepEd-CAR through the Legal Unit conducted a teleconference via Google Meet to draft the Regional Policy on Gender Student Discipline and Non-Discriminatory Responsive (GRaNdSDisM). On June 26, the Chairperson of the GRaNdSDisM Technical Working Committee presented the draft policy during the Review of Proposed Contextualized Guidelines/Policies to review the proposed guideline/policy and recommend approval of the contextualized GRaNdSDisM policy to the management. Afterwhich, on June 29, the DepEd-CAR Regional Policy Guidelines on Student Discipline was released through the Regional Memorandum 173, series of 2020 with the enclosure of the GRaNdSDisM for immediate wide dissemination and strict compliance of the Schools Division Offices, Public and Private Elementary and Secondary Schools, SUCs and LUCs offering basic education.
- 2. To cascade/roll out the policy to its main implementers in the different Schools Division Offices and to ensure the participation of all the schools, a teleconference via Google Meet will be conducted on August 7, 2020; 8:00 AM-5:00 PM.
