

# NAST PHL, ACDP, UP Manila to hold National Substance Use Science Policy and Information Forum

On June 15, 2021, the National Academy of Science and Technology, Philippines (NAST PHL) will partner with the Asian Center for Drug Policy (ACDP) and the University of the Philippines Manila in hosting the very first National Substance Use Science Policy and Information Forum with the theme "Substance Use in the Philippines: Governance, Research, and Practice".

**Substance use (and substance use disorder)** is a complicated issue that should preferably be viewed from a public health perspective placing priority on the needs of the individual. Only a small proportion of PWUDs (persons who use drugs) develop a clinical dependence and this is also dependent on the type of substance. Furthermore, the varying motivations for drug use and its effect within a community requires careful consideration in order to develop informed policy. Despite the growing body of evidence supporting the efficacy of some interventions, there is still a lack of harmonized policy supporting these efforts.

The war on drugs also exposed critical institutional gaps and a need for policy reform. In 2016, after the launch of the drug war in the Philippines, stakeholders have begun acting independently or in small groups implementing their own programs or conducting research. However, the drug recovery journey -- prevention, identification, voluntary intake, treatment and management, and finally aftercare and reintegration -- requires coordination from multiple government agencies, civil society organizations, and other sectors. Also highlighted by the recent activities surrounding drugs is still a need for policy reform.

At the same time, new modalities of community-based rehabilitation programs are being implemented around the country. As a result of the multiple streams of independent activity, the ecosystem has become fragmented. While there have been clear moves to harmonize efforts in recent two years, a gap still exists in the harmonization of policies both in terms of time (new policies are created that are duplicative or in conflict with older ones) and structurally (between government agencies, and levels of government).

The collaborative national forum is organized to achieve the following objectives:

- 1. Present existing evidence in the Philippines on health-centered effective strategies and interventions on the prevention, treatment, and care for people affected by drug use and drug use disorders, employing human rights-based approaches;
- 2. Facilitate the discourse and agreement of the scientific community from different disciplines on a five-year research agenda; and,
- 3. Present the scientific community's evidence-based policy recommendations to national and local policymakers through policy briefs.

Prior of the main conference on June 15, the ACDP organized a series of weekly pre-conference webinars that focused on the following major topics/themes:

- 1. The Global and Local Situation on Substance Abuse: Identifying Key Issues April 21
- 2. Public Health Dimensions of Substance Abuse April 28
- 3. Support Systems for Persons Who Use Drugs May 5
- 4. The Science of Substance Abuse May 12
- 5. Public Health Policy and Interventions May 19

Teams of experts from the various ACDP partners organized the five-part webinar series which facilitated the survey and review of literature and policy implications, identification of research gaps, and preparation of policy briefs.

The major highlights and recommendations for each topic area will then be presented in the national forum. Expected to attend the conference are more than 2000 participants representing the academe (faculty and students), public health advocates, health researchers, national government agencies, non-government organizations, professional organizations, and, significantly, national and local policy makers who may be guided and advised on crafting legislation and policy that is science and evidence based.

At the end of the national forum, a harmonized research agenda and policy framework on substance use is envisioned to be achieved.


