# REITERATION ON QUALITY ASSURANCE OF LEARNING RESOURCES, QA TEAMS, AND FLOW

- 1. In line with the Sulong Edukalidad of the Department and with reference to the BE-LCP and DepEd-CAR's Learning Continuity Operational Plan, this Office, through the CLMD-LRMDS, reiterates and harmonizes previous issuances relative to the development and quality assurance of learning resources.
- 2. To harmonize details stipulated in RM 81, 90, & 91, s. 2020, Learning Resources developed by Teachers, Master Teachers, School Heads, and Supervisors based from the Most Essential Learning Competencies (MELC) shall be subjected to the BLR-standardized evaluation processes and assessment procedures.
- 3. To further guide the SDOs, District Offices, Schools, and Community Learning Centers, the following are to be considered:
  - a. Submission of learning resources shall be done on a monthly-basis instead of quarterly as stipulated in RM 81, s. 2020. This is so the quality assurance team can provide immediate or timely feedback.
  - b. Locally developed LRs shall undergo thorough review and quality assurance at the Division level based on the elements and technical specifications required, before submitting to the Regional Office. After initial review by the RO-LR team, learning resources that have not undergone Division quality assurance shall be returned.
- 4. To facilitate tracking and inventory, soft copies of Learning Resources being submitted to the Regional office shall be labeled using the filename format below and sent through the following official email address:


