As the Department of Education moves towards a competency-based Human Resource (HR), the perspective on people as its most important resource focuses now on the goal of continuously enhancing the competency of DepEd's workforce in public service excellence. The national adoption of the Professional Standards for Teachers, School Heads, and Supervisors underpins efforts to integrate and provide a sound and logical basis for actions under various HR systems in the department, foremost of which are the recruitment and promotion system via career progression, results-based performance management system, and the learning and development management system.

DepEd continues to strengthen its human resource through Learning and Development (L&D) interventions--DepEd L&D, formerly titled as Training and Development (T&D) as per DepEd Order No. 32., s. 2011 as an inherent mandate of the department to support and promote the professional development of its personnel. This effort is also in compliance with CSC Memorandum Circular No. 3, s. 2012 or the Program to Institutionalize Meritocracy and Excellence in Human Resource Management (PRIME-HRM).

Last September 2020, the Bureau of Human Resource and Organizational Development - Human Resource Development Division (BHRO-HRDD), in collaboration with the National Educators Academy of the Philippines (NEAP), started to develop the draft L&D policy which aims to establish a competency-based L&D standard for both teaching and non-teaching personnel.

In line with the foregoing, the BHROD-HRDD and NEAP are set to conduct a two-part consultation workshop on the following schedules:
