- 1. In view of the vision of the Indigenous Peoples Education Program of DepEd-CAR to continuously improve program implementation vis-à-vis stakeho ders support, this Office will hold a one-day meeting with the Regional Executive Council of Elders on September 18, 2017 commencing at 10:00 AM at the Mini Conference Hall (inside the RO Canteen).
- 2. This meeting aims for the participants to: clarify concerns re the involvement of elders in IPEd activities; and establish agreements as to the participation of elders in IPEd activities.

Lodging of Elders will be at the NEAP Domittory.

Dear Madam Sor,

Greetings from the mountains of the Cordilleras!

We, the CAR Regional IPEd Council Elders, would like to reach out to you to raise certain pressing concerns regarding our current practices of indigenizing the curriculum in CAR. We know you are very busy but we would like to submit to you our collective sentiments because of the urgency of this matter since it is dealing with our culture and identity as a peoples.

We have made the following observations

- 1. There seems to be no proper and full participation of the communities in the indigenization implementation of the different Divisions in CAR. This is a general sentiments in the different Divisions.
- 2. Relatedly, one reason for this is the lack of initiative from DepEd to prepare properly the elders to be involved in the process of indigenizing the curriculum.
- 3. And we observed that due to the lack of participation by the communities, the DepEd side seems to arbitrarily interpret the IKSPs according to DepEd understanding, missing the real meanings and knowledges from the community.
- 4. There seems to be a need to level off and properly understand the IKSPs as a knowledge system as also indicated by Dephid Order \$1. s. 2014

Allow us to humbly and respectfully make these recommendations,

- 1. We strongly recommend that at the soonest possible time, (we recommend this May), the Region prepares and conducts a two-full days conference on community engagement and the indigenization processes in CAR
- 2. The first day would be devoted for the discussion-sharing among the elders only.
- 3. The second day would be a dialogue between the elders and the DepEd.
- 4. The conference would be attended by the following from the DepEd side:
 - a. Regional and Division IPEd Focal Persons
 - b. Division CID Chiefs and the Regional CLMD Chief
 - c. Schools Division Superintendents or Assistant Superintendents
- 5. The elder representatives would be from the different ICCs to be ascertained by the Division IPEd Focal Persons
- 6. Expected outputs would be:
 - a. agreements regarding the IKSPs
 - b. administrative matters involving the IPL d Council of Elders
 - c. clarifications and response to questions being raised by the communities

We are looking forward to see you soon. In solidarity with the Indigenous Peoples; may I remain;
