

- 1.  - c. set and synchronize quarterly target deliverables for 2025 in collaboration with Regional and Division Coordinators, ensuring alignment with the overarching objectives of RA 11650.

Regional Focal Persons will receive the agenda, meeting link, date, and time at least one week prior to each scheduled meeting and are responsible for cascading the meeting details to the concerned Division Focal Persons and ILRC Coordinators.

 - a. review the current status of Inclusive Learning Resource Centers (ILRCs);
 - b. map and assess the availability of Professionals for the Multi-Disciplinary Team of ILRCs; and
 - c. identify successes and challenges in the provision of ILRC services.
