

ONLINE VALIDATION AND TRACKING OF THE STATUS OF PRIVATE SCHOOLS OPERATING BASIC EDUCATION

To: Assistant Regional Director Schools Division Superintendents Private School Administrators All Others Concerned

- 1. The Government recognizes the important role of private schools in the delivery of basic education hence the enactment of Batas Pambansa Bilang 232 otherwise known as the "Education Act of 1982". To implement such law, DepEd Order No. 88, s. 2010 (2010 Revised Manual for Operations of Private Schools in basic Education) was released as basis for the establishment and operations of private schools that will offer basic education curriculum.
- 2. For monitoring and evaluation, this office through the Quality Assurance Division (QAD) wish to validate and track the present status of all private schools operating basic education in the region through online questionnaire considering the economic challenges which affected educational institutions.
- 3. All private schools that are in operation as of School Year (SY) 2021-2022 are directed to answer with substantial and accurate information the online questionnaire at https://tinyurl.com/OVPS2022. Schools Division Offices are likewise advised to closely monitor and provide technical assistance to private schools to ensure compliance to this memorandum.
