## IMPLEMENTATION OF THE SCHOOL-BASED FEEDING PROGRAM FOR SCHOOL YEAR 2016-2017

To: All Schools Division Superintendents

- The School -Based Feeding Program (SBFP) shall be implemented in the region for School Year 2016-2017 pursuant to DepEd Order No. 51, s. 2016 Re: Implementation of the School-Based Feeding Program SY 2016-2017.
- The feeding activity shall cover 6,678 severely wasted and wasted pupils from Kindergarten to Grade 6 in the region based on the actual nutritional assessment taken from June-August 2016. The program aims to improve the nutritional status of the beneficiaries to normal status by at least 70% at the end of 120 feeding days, increase class attendance by 85% and improve the pupil's health and nutritional values and behavior.
- 3. School heads involved are expected to monitor the preparatory activities like the feeding area, kitchen facilities and paraphernalia, involve/engage parents and other stakeholders to support the program and ensure the monthly liquidation of funds.
- The Regional/Schools Division Technical Working Group (R/SDTWG) is expected to monitor 4. the school compliance with the operational guidelines enclosed in the DepEd Order. The Regional Technical Working Group (RTWG) shall monitor the activities of the schools division offices, such as the timely release of funds to the school heads, progress of implementation, timely liquidation of funds and submission of reports.
- It is requested that the list of schools and beneficiaries using SBFP Forms 2 and 3 shall be submitted to the Education Support Services Division, DepEd- CAR Wangal, La Trinidad, Benguet on or before September 30, 2016.
- All school terminal reports shall be submitted to the Schools Division Office through the District Office, then to the DepEd Regional office thirty (30) days after the end of the feeding activity using the SBFP Forms 5 and 6A-D to the Education Support Services Division, DepEd- CAR Wangal, La Trinidad, Benguet with email address essd.depedcar@gmail.com to be consolidated and submitted to the Bureau of Learner Support Services (BLSS) - School Health Division.
