- 1. Relative to the Department of Education's desire to intensify its campaign on COVID-19 and align its efforts and initiatives with the advocacies of the Department of Health and the National Inter-Agency Task Force for Emerging Infectious Disease (IATF-EID), all DepEd CAR offices and schools are enjoined to support DepEd's Vacc2School Campaign "Ligtas na Bakuna Para sa Balik-Eskwela.
- 2. The Vacc2School Campaign aims to:
 - a. inform and engage the Department's stakeholders, especially teachers, in the promotion of vaccination and other related policies to mitigate COVID-19;
 - b. maximize available platforms for the contextualized BIDA Solusyon Plus COVID-19 campaign of DepEd; and
 - c. aid the Department of Health (DOH) and the Interagency Task Force on Emerging Infectious Diseases (IATF-EID) in promoting the BIDA SOLUSYON Plus campaign in the education sector.
- 3. Hence, all offices and schools are to carry out the following activities:
 - a. achievement of at least 75% (of the total number of personnel) vaccination rate in the office or school before the opening of the new school year,
 - b. hanging of Vacc2School streamers, banners, infographics, and posters on conspicuous areas of the school premises,
 - b. conduct of Vacc2School advocacies (RESBAKUNA) during LAC sessions, PTA meetings, and other limited face-to-face engagements to be facilitated by School Health and Nutrition Personnel or the Rural Health Units,
 - c. active and continuous advocacy on social media through the DepEd Tayo Facebook pages by sharing infographics, FAQs, and other social media collaterals on COVID-19 from legit sources like DepEd Philippines, DepEd Tayo Cordillera and the Department of Health pages,

- d. putting up of bulletin board within the campus and display any informative materials concerning the importance of COVID-19 vaccination, and
- e. use of the prescribed social media profile picture frame on Facebook accounts and pages.
- 4. Moreover, the Schools Division Offices are expected to submit the following for social media collaterals for both Facebook and TikTok pages:
 - a. 1-minute video message of Schools Division Superintendents and Assistant Schools Division Superintendents in support to COVID-19 vaccination,
 - b. Quotes or testimonials from personnel (including their photo doing the V-Sign or Thumbs Up gestures) who were vaccinated to be used as motivational cards or testimonial cards; and
 - c. 1-minute dance in support to COVID-19 vaccination by office or school personnel.
- 5. The video messages, dances for TikTok videos, and quote or testimonial cards to be submitted to the Regional Office must be of high quality and already edited with the necessary prescribed Vacc2School co-branding, logos and art direction. Submission of these collaterals through car.pau@deped.gov.ph must not be later than July 16, 2021, however, posting on SDO DepEd Tayo Pages shall commence immediately.
- 6. Meanwhile, the videos for TikTok will be posted at the official TikTok page of DepEd CAR, **DepEd Cordillera**.
