- 1. The Legal Unit and ICT Unit under the Office of the Regional Director will launch the LSIS 2.0 on November 7, 2016 AM and capability building of the members of the division's formal investigation committee and regional / division child protection council on November 7, 2016 PM to November 8, 2016.
