

## REGIONAL ONLINE ORATORICAL CONTEST IN ENGLISH AND FILIPINO

To: Assistant Regional Director

- The Department of Education-Cordillera Administrative Region (DepEd-CAR) through the Curriculum and Learning Management Division (CLMD) shall conduct the Regional Online Oratorical Contest in English and Filipino in the celebration of the 35th Cordillera Month with the theme, One Autonomous Cordillera: Ensuring Social Development and Inclusive Growth in the New Normal.
- 2. The objectives of this activity are to:
  - a. Provide an opportunity for teaching and non-teaching personnel to demonstrate their verbal proficiency through oration;
  - b. Increase teaching and non-teaching personnel willingness to communicate their thoughts and feelings.
- 3. SDOs shall instruct their participants on the conduct of the online oratorical contest following the mechanics stipulated in paragraph 5. First Place winners for each SDO per category for elementary and secondary teaching and non-teaching personnel shall be qualified for the regional level online oratorical contest. Each SDO shall submit only two (2) entries or contestants, distributed in the table below:

- Said activity is open to both public and private schools for teaching and nonteaching personnel including job order.
- 5. Please be guided by the Contest Mechanics specified below.



- a. Each participant must **compose** and **deliver** his/her own oration relative to the theme stated in paragraph 1.
- b. The delivery of the oration should last for 2 to 5 minutes including the entrance and exit. The contestants are allowed to read their oration and can strategize on how they deliver it.
- c. Contestants must be in school uniform. No other props and costume should be used in the delivery of the piece; therefore, digital and musical instruments sound effects will not be allowed.
- d. Entries will be submitted through avp. Videos should have a minimum resolution of 720p (16:9) to optimal 1080p (16:9) and may be saved in .vmw,.mov,.mp4, or .mpg file formats before submitting through the Online google form through this link: https://tinyurl.com/EntriesNTPandTP.
- e. The winners will be chosen based on the following criteria:

CRITERIA	PERCENTAGE
Content-the oration is relevant with the theme, original,	25%
interesting and well supported argument	
Performance-the orator engages the audience, pronounce	20%
all the sounds and words clearly and with emotions and	
body gestures	
Fluency- the oration is well structured (has beginning,	20%
middle and end), well - structured and proper grammar	
Voice Quality-the orator use proper volume, tone variation,	20%
pacing, and timing to show expression	
Professionalism-the orator uses proper formality greetings,	10%
give appropriate introduction and conclusion and show	
politeness	
Time Management- the orator does not go over or under	5%
the designated time

- 6. All contest entries must be submitted online on or before July 25, 2022 until 5:00 o'clock in the afternoon. Late submission of entries will not be considered.
- 7. All participating personnel shall receive certificate of participation and recognition. Awarding of certificates will be given during the culminating day on July 29, 2022.
- 8. To assist the team in judging the oratorical contest, the RO personnel are requested.
