

- 1. To continuously ensure the effective and efficient provision of Legal Services to all women and men stakeholders, female and male learners in the region, the Office of the Regional Director through the Legal Unit in coordination with the Schools Division Office of Abra, will be conducting a Mid-Year Interface with SDO Counterparts;
- 2. Women and men representatives from all the eight (8) Schools Divisions, and Regional Office Legal Unit personnel will participate in this activity on **June 19-21, 2024** at a venue to be announced later;
- 3. The objectives of the activity are:
  - a. To establish a uniform monitoring system for the implementation of administrative cases that have become final and executory;
  - b. To conduct planning activities for the capacity building of learners and student leaners for them to lead in the creation and/or strengthening of Rights Upholding Learning Environments (RULE) including Rights-Upholding Schools (RUS), and Rights Upholding Community Learning Centers (RUCLC)in line with Project DepEd-CAR CHILD Rights (DepEd CAR Committed and Holistic Integration of Learner's Development Rights);
  - c. To establish a uniform monitoring system in the implementation RM NO. 273, S. 2024 (Inclusion of Submission and Updating of School Sites Proof of Ownership Documents to the Schools Division Office in the OPCRF of School Heads/Principals;
  - d. Other Legal Services;
