The Department of Education (DepEd), through the Bureau of Human Resource and Organizational Development – School Effectiveness Division (BHROD-SED), is currently undertaking the amendment of the Special Hardship Allowance (SHA) policy in partnership with the United Nations Children's Fund (UNICEF).

In support of this effort, the Regional and Division Planning Officers, through coordination with Planning Service-Educational Management Information Systems Division (PS-EMISD) and BHROD-SED, are currently conducting school data validation activities that will inform the recalculation of HI scores across all schools.

Further, the BHROD-SED previously conducted consultation workshops with select Planning Officers, Finance, and Personnel Officers to review the current policy provisions and propose necessary changes. The identified suggestions concentrated on the eligibility criteria, set of hardship variables, and the presence of an appeal mechanism for schools' inclusion as hardship post.
