- In pursuance of Regional Memorandum No. 308, s. 2016 entitled, Monitoring the Implementation of the K to 12 Curriculum, DepEd-CAR through the Curriculum and Learning Management Division, will conduct a series of monitoring and validation activities from November 28 to December 9, 2016.
