

**ADJUSTED TIMELINES ON THE CONDUCT OF THE 2021 NQESH**

To: Assistant Regional Director  
Schools Division Superintendents  
Members, NQESH RTWG and DTWG  
All Others Concerned

1. With the changes in the National schedules on the conduct of the 2021 National Qualifying Examination for School Heads (NQESH), it was agreed during the meeting and orientation among the members of NQESH RTWG, DTWG and the examinees last June 27, 2022, that the timelines of the regional activities shall likewise be adjusted. The final implementation plan for the conduct of 2021 NQESH is enclosed in this memorandum.
2. To mitigate the problem on poor internet connectivity, possibility of power block outs and other disturbances, examinees shall be housed at the NEAPR during the mock tests and the examination proper.
3. Expenses of examinees during the mock tests and examination proper may be charged against available and applicable local funds while the cost of seminar/capability building shall be charged against NEAP/HRTD Funds subject to accounting and auditing rules and regulations.
4. The collected examination fees shall be used to pay the honoraria and meals of personnel who will serve during the NQESH examination day and other related expenses. Service credits or Compensatory Time-off (CTO) may be granted to personnel who will render services during Saturdays, Sundays or holidays in relation to the conduct of the NQESH as per DepEd Order No. 53, s. 2003, Updated Guidelines on Grant of Vacation Service Credits to Teachers.
