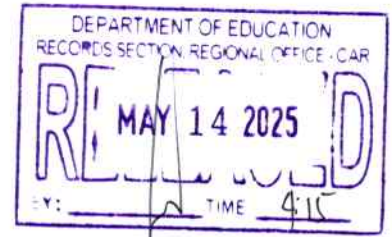

The Department of Education Cordillera Administrative Region continuously implements the Oplan Kalusugan sa DepEd (OKD) Program which aims to promote and provide all learners and DepEd personnel with a sustainable and holistic school health and nutrition program. Anchored in this are the six (6) flagship programs namely, School-Based Feeding Program, National Drug Education Program, Adolescent Reproductive Health Program, Medical Dental and Nursing Services, Water, Sanitation and Hygiene in Schools (WASH in Schools), and School Mental Health Program.
