

- 1. Pursuant to DepEd Order No. 83, s. 2012 "Implementing Guidelines on the Revised School-Based Management Framework, Assessment Process and Tool (APAT) and Regional Memorandum No. 81, s. 2021 "Guidelines on the Enhanced and New Processes of School-Based Management (SBM) Level of Practice Validation for 2021, the Field Technical Assistance Division (FTAD) is accepting endorsements for the conduct of online SBM Level of Practice validation of schools.
