

## RECOMMENDATION OF SCHOOLS FOR DEPLOYMENT OF PROJECT "RESILIENT EDUCATION INFORMATION INFRASTRUCTURE FOR THE NEW NORMAL (REIINN) OF THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST)

To: Assistant Regional Director Schools Division Superintendents All Schools Division Offices All Others Concerned

- This is in relation to the letter of DOST-Regional Office requesting our office to recommend schools in the region as potential recipients of the Project REINN.
- Anent to this, SDOs are requested to submit list of potential schools for the installation of LokaLTE Base Tower and Rural Casting Set-Top Box. The criteria for selecting possible sites are as follows:
  - a. Absence of commercial mobile phone service or signal to avoid any interference;
  - b. The school is not more than 500 meters away from a community with at least 50 households:
  - c. School officials and members of the community are willing to participate and cooperate in the project;
  - d. No ongoing armed conflict or other serious peace and order issue;
  - e. Availability of passable roads even during rainy seasons;
  - f. Preferably with reliable electric power from the local utility; and
  - g. Has an open space area to host the LokaLTE cell site of the following:
    - Ground space of at least 8m x 8m, preferably away from other infrastructures.
    - Building rooftop space, which is subject to an inspection of the project's structural engineer for feasibility.
