REGIONAL MEMORANDUM

Reiteration on the Distribution and Utilization of Self Learning Modules (SLMs) and Learning Resources (LRs)

TO: OIC-Assistant Regional Director
Regional Office Division Chiefs
Schools Division Superintendents
Public and Private Elementary and Secondary School Heads
All Others Concerned

1. Pursuant to DepED Order No. 12, s. 2020 (Adoption of the Basic Education Continuity Plan for School Year 2020-2021 in the light of COVID-19 Public Health Emergency), specifically on the provision of access to appropriate, quality learning resources, DepED-CAR initiated the development of contextualized SLMs which aim to provide learners with basic material for continuity of learning.
2. Relative to this, this office reiterates to all Schools Division Offices that all locally-developed SLMs and LR in all learning areas in all grade levels must undergo **thorough quality assurance process** at the Regional Offices before distribution to learners and/or uploading to SDO LR Portal.
3. The SDOs are expected to conduct orientation to supervisors, school heads and teachers to communicate the guidelines that NO module shall be distributed to the learners unless quality assured at the Regional Office. Further, Schools Division Superintendents and School Heads shall be held accountable for any SLM and LR utilized in their respective Divisions and Schools found to have violations to LR standards.
4. Learning area supervisors shall monitor utilization of the SLMs and LR and give report as to the issues and concerns relative to the materials' accuracy and effectiveness. Public Schools District Supervisors and School Heads are tasked to monitor the distribution and utilization of SLMs and LR in their respective locations.
5. An "Error Watch Mechanism" shall be tied up with the LR Helpdesk. Please address all LR or SLM-related concerns through lrmshelpdesk.depedcar@gmail.com. Posting on facebook is highly discouraged. Only concerns addressed through the LR Gmail account shall be addressed.
