



## FINANCIAL ASSISTANCE TO THE PILOT INTEGRATED SCHOOL NUTRITION MODEL (ISNM) LIGHTHOUSE AND SCHOOLS WITH GULAYAN SA PAARALAN PROGRAM AS LIGHTHOUSE EXPANSION

- 1. Per announcement during the Orientation/Consultation on the Milk Component of the School-Based Feeding Program last October 14-16, 2019 held at Tanza Oasis Hotel, Tanza, Cavite, the DepEd-CO will download funds to the Pilot Integrated School Nutrition Model (ISNM) Lighthouse Schools and to five (5) schools per region implementing Gulayan sa Paaralan Program (GPP) to be established as lighthouse schools.
- 2. The following are the ISNM Lighthouse Schools and five (5) schools to be given Ten Thousand Pesos 10,000.00 each:

- 3. The funds will be used for the enhancement of the school garden in the establishment of seedling nursery, seed banks, fencing or organic inputs to sustain the school garden.
- 4. Identified schools are encouraged to visit the ISNM Lighthouse schools to benchmark on how to establish a Lighthouse School.
- 5. Lighthouse schools serves as model, having maintained a school garden; Crop Museum where indigenous vegetables are preserved year round; conduct seed exchange with other schools and the community; intensified nutrition education and strong partnership with stakeholders.
- 6. The schools division offices are requested to monitor the schools and to include in the 2019 Gulayan sa Paaralan Program Report, activities undertaken by the schools in the improvement/enhancement of the school gardens.
- 7. Immediate and wide dissemination of this Memorandum is desired.
