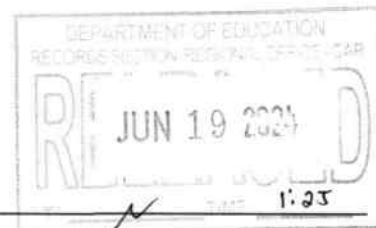

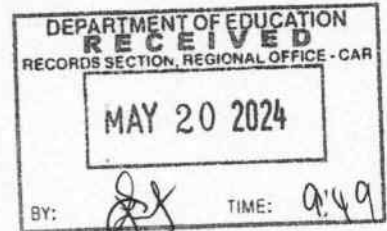

The Department of Education (DepEd) through the Bureau of Learner Support Services-School Health Division (BLSS-SHD), will conduct the Random Drug Testing (RDT) among secondary learners and DepEd Personnel (teachers and non-teaching) for the School Year 2024 to 2025. The said activity is part of the comprehensive Preventive Drug Education Program of the Department as per DepEd Order No. 40, s. 2017, entitled "Guidelines for the Conduct of Random Drug Testing in Public and Private Secondary Schools" and a component of the Wellness Program for DepEd Officials and Personnel, as stipulated in DepEd Order No. 37, s.2017, entitled "Department of Education Drug-Free Workplace Policy."

In this light, this Department will conduct the Orientation of Random Drug Testing nationwide in four clusters. The participants to the activity are composed of the following:

- a) Regional Office: two (2) participants
