"Kumustahan" and Enhancement Training Workshop for ALS

- The Department of Education Bureau of Learning Delivery (BLD) through DepEd CAR
  Regional Office will conduct the Kumustahan and Enhancement Training for Alternative Learning
  System (ALS) implementers in CAR on December 11-15, 2018 at Banaue Hotel, Banaue Ifugao.
- 2. The Kumustahan and Training aims to:
  - 1. Update all ALS implementers in CAR on the intensification and expansion of ALS implementation in the different divisions;
  - Clarify issues and concerns for a common understanding on the processes and needs
    of ALS implementation from the national to the region, division, districts and schools
    or Community Learning Centers (CLC) level;
  - 3. Acquaint ALS implementers and stakeholders on the involvement and importance of ALS in the different schools and communities.
  - 4. Enhanced skills to improve the delivery of the program
  - Assess the program implementation per district and division and make an adjustment to improve for 2019 implementation
- 3. Cognizant to the trust of the Department for quality "Education for All" that nobody shall be left behind, the DepEd-CAR will intensify and expand the ALS implementation by involving all stakeholders in the community. All schools heads, elementary and secondary shall designate their school ALS/ADM coordinator to coordinate relevant and liberated educational activities for active involvement of the community and its people for inclusive education. This will help to raise the school performance.
- 4. Consolidated list of designated school ALS/ADM coordinators in the public elementary and secondary will be submitted on or before December 5, 2018 through email add <a href="mailto:martalamayan@yahoo.com">martalamayan@yahoo.com</a>.
- 5. Schools Division Offices (SDOs) are required to bring with them their ALS tracking report per implementer, issues and concerns, and accomplishment reports. Presentation of 2018 accomplishment per division will be fifteen minutes.
- Registration and check-in shall be on December 11, 2018 at 9:00 AM and check out will be on December 15, 2018 at 1:00 P.M.. First meals to be served will be AM snack on December 11,2018 and last meal will be lunch on December 15, 2018.
