

REGIONAL MEMORANDUM No. $435 \cdot 2021$

CORRIGENDUM TO REGIONAL MEMORANDA NOS. 333, 340, AND 349 S. 2021 (LIMITED FACE-TO-FACE AND ONLINE VALIDATION OF SBM LEVEL OF PRACTICE)

Due to the rising COVID-19 cases in the Cordillera and to ensure the health and safety of all concerned personnel, the following corrigenda shall take place to rectify provisions in the following memoranda:

Paragraph 1 of RM 333, s. 2021 stating ... "onsite validation for SDO Mountain Province on September 20-24,2021..." is cancelled;

Paragraph 3 of RM 340, s. 2021 stating ... "schools ready for Level 2 and 3 to take the online platform on specified schedule" shall be deferred; and.

Paragraph 2 of RM 349, s. 2021 stating ... "School-based Management (SBM) Level 3 shall be validated onsite" shall be changed to online validation.

- 2. Schools endorsed for **Level 3** shall upload documents to be assessed by Regional SBM Task Force Core Team prior to the conduct of a virtual conference/final assessment with the Regional SBM Task Force Management Team (RD Cariño, OIC-ARD Vergara and respective Chief/guardian of the concerned SDO). During the final assessment, schools are directed to present real-time or raw video of schools' physical resources and facilities.
- The proposed schedule for the regional online SBM validation for Level 3 schools are as follows:

Apayao	October 1, 4, 6-8, 11-12, 2021	October 13, 2021
*Abra	October 14-15, 18-19, 2021	October 20, 2021
*Kalinga	October 21-22, 25 2021	October 26, 2021
*Tabuk City	October 27-29, 2021	November 3, 2021

Note: *Schools validated onsite last June 2021 which need to complete the documents for SBM Level 3 (Reference: RM No 212 s 2021)



- For the Level 2 certification, the SDO SBM Task Force is directed to 4. validate schools for recognition as practicing Level 2 starting September 27, 2021 considering the guidelines stipulated in RM 278, s. 20191. Results of the validation for Level 2 shall be submitted to the Regional SBM Task Force on or before December 1, 2021 for confirmation. The SDO SBM Task Force Chairperson (SDS) shall issue SBM level of practice certifications and recognize the validated schools during the SBM Congress².
- Meals of the validation team during the conduct of the online SBM Level 3 5. validation activities shall be charged against the regional office funds subject to usual budgeting, procurement, accounting and auditing rules and regulations.
- 6. Other provisions of the aforementioned memoranda shall remain in place.
