In compliance with DepEd Order No. 14, s. 2018 titled Policy Guidelines on the Administration of the Revised Philippine Informal Reading Inventory, the Regional Office directs all English and Filipino teachers in the Schools Division Offices to conduct the Phil-IRI PRETEST to learners in Grades 3 to 7 in all public elementary and secondary schools who scored below 14 in the Group Screening Test (GST). This shall be conducted from September 1 to October 14, 2022.

2. The Focal Persons for Phil -IRI in English and Filipino in each Schools Division Office (SDO) shall facilitate and collate the results of Pre-Test by accomplishing all the sheets (Sheets A to D plus Summary of Results for English and Filipino) found in in the google sheet link corresponding their SDO on or before October 31, 2022.

- Learners who are identified under the frustration and nonreader levels (both in oral and comprehension) shall be provided with necessary interventions such as but not limited to intensive remediation and school-home partnership. An Intervention Plan shall be prepared and submitted to the Schools Division Office for consolidation and submission to the Regional Office - CLMD.
- 4. School Heads and Language Supervisors shall provide necessary support to upskill and reskill teachers in the provision of appropriate interventions and shall ensure that learners will transfer to higher grade level equipped with required decoding and comprehension skills.
- A schedule of monitoring from the Regional Office shall be made to ensure 5. the implementation of Phil-IRI in all schools in the region.
