


REGIONAL MEMORANDUM No. 502 2022

REQUEST FOR THE DESIGNATION OF DIVISION CIRCLE OF INNOVATORS FOR LEARNING (CIL) COOORDINATOR

To: Assistant Regional Director Schools Division Superintendents All Divisions Others concerned

- 1. Relative to **DepEd Memorandum No. DM-CI-2022-352** titled "Request for the Regional and Division Focal Person & Selection of Members of the Circles of Innovators for Learning (CIL)," this Office requests each division to designate a division CIL coordinator. The division CIL coordinator shall have the following duties:
 - a. Serves as official division representative of the Circle of Innovators for learning;
 - b. Helps the division office in the promotion and inculcating innovations for learning in the division;
 - c. Coordinates with the National Technical Working Group of the Circles of Innovators for Learning in related programs, projects and activities;
 - d. Spearheads the identification and selection of innovations within the division;
 - e. Conducts monitoring and evaluation of innovations for learning within the division;
 - f. Establishes strong linkages and partnerships:
 - g. Conducts relevant activities on the innovations for learning; and
 - h. Creates and manages directory/database of innovators for learning of the division.
- 2. Corollary to this, the designated division CIL coordinator must satisfy the following:
 - a. Must be a DepEd Teacher/Head Teacher/Master Teacher/ Supervisor/ Chief/Assistant Schools Division Superintendent/Schools Division Superintendent with at least three (3) years of continuous service;
 - b. Must have a performance rating of at least very satisfactory;
 - c. Must have an exemplary innovation replicable and scalable to influence the quality of Philippine or Global Education;
 - d. Must have been recognized by an award-giving institution based on what he/she created, improved, or innovated in the service and/or program which benefitted the DepEd Community; and
 - e. Must have exhibited good moral character and must not have been charged guilty in any administrative, civil, or criminal case.
