#### 2022 NATIONAL OBSERVANCE OF THE FILIPINO VALUES MONTH

- 1. Presidential Proclamation No. 479 titled Declaring the **Month of November of Every Year as Filipino Values Month** signed on October 25, 1994, by the late President Fidel V. Ramos to create moral awakening and national consciousness on human values that are unique, genuine, and positively Filipino. With this declaration, Filipinos of all ages and from all sectors of the society are enjoined to actively participate in this annual observance.
- 2. Relative to DepEd Memo. No. 101, s. 2022 titled 2022 National Observance of the Filipino Values Month, the Department of Education (DepEd) shall join in the celebration of the 2022 National Observation of the Filipino Values Month with the theme, Magandang Kaugaliang Pilipino:Isabuhay at Pagyamanin Tungo sa Matiwasay at Maunlad na Kinabukasan. This year's theme focuses on how Filipino values can be strengthened and exercised in the life of each Filipino can contribute to nation-building and achievement of individual and national goals.
- 3. All schools, both public and private are encouraged to integrate Filipino values in the teaching-learning activities, not only in *Edukasyon sa Pappapakatao (EsP)* but also be incorporated in the activities of the different celebrations of the month, such as the:
  - a. National Children's Month;
  - b. Economic and Financial Literacy Week;
  - c. Global Warming and Climate Change Consciousness Week;
  - d. Araw ng Pagbasa;
  - e. National Week for the Gifted and Talented,
  - f. National Science and Technology Week; and
  - g. Other Co-curricular activities.
- 4. Activities relative to the observance of the Filipino Values Month (FVM) shall be held by DO No. 9, s. 2005, titled Instituting Measures to Increase Engaged Timeon Task and Ensuring Compliance Therewith and DO 034, s. 2022, titled School Calendar and Activities for the School Year 2022-2023.
- 5. The division offices shall submit a comprehensive report that describes the activities implemented in both public & private schools in relation to the observance of the FVM following the enclosed template through the email address at <a href="mailto:car.clmd@deped.gov.ph">car.clmd@deped.gov.ph</a> and/or <a href="mailto:corazon.alos@deped.gov.ph">corazon.alos@deped.gov.ph</a> not later than Dec. 15, 2022.
